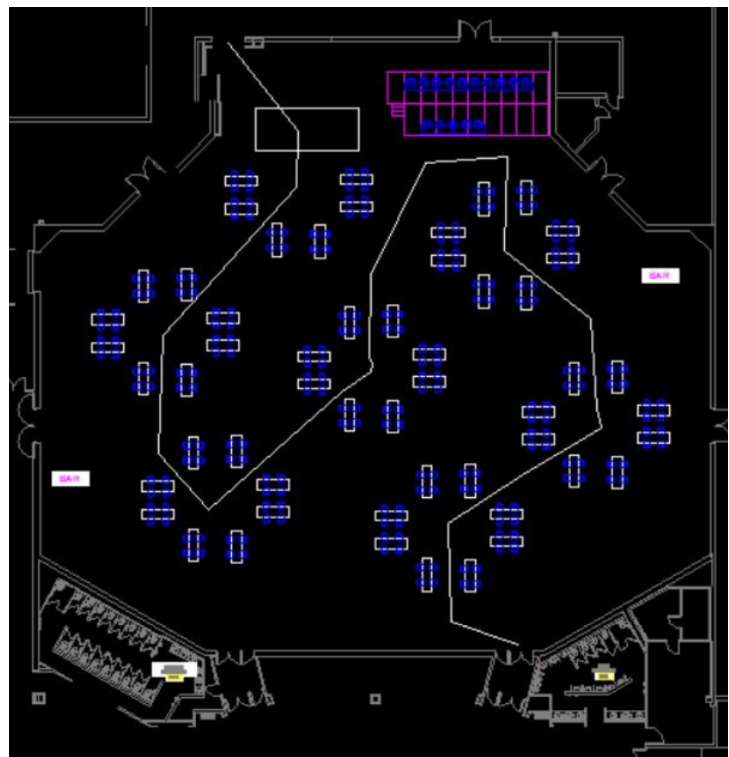

# 2020 RAW FUSION MODEL INFORMATION

**DESIGN NOTE: Masks Required**  
**Stage is 4 Feet Wide - Plan Accordingly.**  
**Models MUST fit through a standard door frame 3' x 7'**  
**Models MUST be able to get up stage stairs un-assisted.**

## 2020 ENTRY RULES

- Model agrees to be present at the event in costume by 4:00pm, Friday, November 13, 2020  
Time and order of appearance on stage will be decided by Raw Fusion Planning Committee and handed out to models at Dress Rehearsal (Thursday, November 12).
- Failure to appear for show will result in an added fee of \$50.
- Model must be 18 years of age and older.
- Model urged to have costume ready one day before event.
- Model must be at 2-hour dress rehearsal scheduled for one day before the show (Thursday, Nov. 12, 2020 @ 5:30pm).
- **Model/Designers will contact executive director, Kaaren Grabianowski for concept/materials consultation.**

## COSTUME DESIGN DETAILS

- MASKS REQUIRED ON MODEL - have fun with this!
- Nudity is not allowed. Nudity of any kind will result in disqualification of model with no refund on entry fee
- **At least one aspect of the outfit must be made using raw building materials** (examples, but not limited to quartz, tile, glass, wood, metal, paper, landscaping materials, anything you might utilize in the construction or furnishing of a home)
- Costume idea and concept will be critiqued and reviewed by Kaaren Grabianowski to determine eligibility of costume.
- One assistant per model is allowed to accompany model behind stage (Assistant not required) Assistant will be required to wear identification given by staff.
- Costume design is subject to ongoing critique of judges prior to event to ensure costume abides by rules
- No paints, over-sprays or flammables allowed to be brought on premises.
- No helium balloons allowed on Raw Fusion runway.
- No animals allowed.

Model agrees to appropriate screening process with Raw Fusion Planning Committee to ensure model is abiding by the rules and guidelines of Raw Fusion Fashion Show 2020 at all times. These rules and guidelines are subject to change at any time at the discretion of Raw Fusion Planning Committee. Raw Fusion is not responsible or held liable for any injury that occurs to model, including, but not limited to creation of costume, practice run-through of event or during the event. Raw Fusion is also not liable for lost or stolen items.
